GENERAL ORDER REGARDING ASSIGNMENT OF CASE NUMBERS AND
DIVISIONAL VENUE TO CASES FILED OUT OF DISTRICT

Bankruptcy petitions are occasionally filed in the Southern District of West Virginia by debtor(s) who reside in a federal judicial district other than the Southern District of West Virginia. Such out-of-district cases are permitted to proceed in this District, absent a motion to transfer the case. In order to aid in the administration of these out-of-district cases, the Court has determined that such cases should be assigned a case numbers and divisional venue according to the division of the Court that is closest in proximity to the residence of the debtor(s). Accordingly, it is

ORDERED that, effective May 15, 2007, bankruptcy cases filed in the Southern District of West Virginia, by debtor(s) who reside in the counties listed on **Exhibit A attached to this Order**, shall be assigned divisional venue and a case number that corresponds to that divisional venue, as reflected on Exhibit A. The case shall proceed in that divisional venue, unless motion to change the divisional venue is filed. Out-of-district cases filed by debtors residing in counties other than those listed on Exhibit A shall be assigned to the Charleston division.
